2. In compliance with Regulation 33 of the Securities Exchange Board of India ("SEBI") (Listing Obligations and Disclosure Requirements) Regulations, 2015, a limited review of financial results for the quarter ended 31st December, 2020 has been carried out by the Statutory Auditors.

3. The Unaudited Financial Results for the quarter and period ended 31st December, 2020 have been reviewed by the Audit Committee at their meeting held on 09.02.2021 and thereafter approved by the Board of Directors at their meeting held on that date.

4. During the quarter, operations of the Company were mildly impacted due to restrictions imposed to control the spread of COVID-19 pandemic. The impact of the Covid-19 pandemic on future business operation of the Company may be different from that estimated as at the date of approval of these unaudited quarterly financial results considering the uncertainty in overall economic environment and the Company will continue to closely monitor any material changes to future economic conditions. 5. The Company has One Segment only viz. Investmen and Loan activities. Thus Segment reporting is not applicable.

6. Provisions for Taxation and any other provision if required will be made at the end of the year.
